

IF YOU ARE REPLACING YOUR ROOF, AN EXTERIOR DOOR, OR FENCE, CUTTING DOWN A TREE, OR ADDING A GAZEBO, ETC., ALL OF THESE IMPROVEMENTS MUST BE REVIEWED AND APPROVED BY THE ARC BEFORE YOU CAN PROCEED. BEFORE INSTALLING A NEW ROOF, YOU MUST PRESENT YOUR ROOFING CONTRACT TO THE ARC FOR APPROVAL.

ALL THE ROOFS MUST BE IDENTICAL. THE SHINGLE TYPE IS EITHER TAMKO OR TIMBERLINE GAFC. THE COLOR IS "WEATHERED WOOD."
